- 2. Submit PAN OR Aadhaar Details.
- 3. Enter your details like, name, date of birth, mobile, etc.
- 4. Enter captcha and click on "Get Authorisation PIN".
- 5. The UAN Number will be sent to the registered mobile number.

- 2. Enter the 16 digit Demat account number and password.
- 3. Once you register, view or download your Demat holdings.

NSDL

- 1. Visit https://eservices.nsdl.com
- 2. Click on Register online for IDeAs.
- 3. *Enter your DP ID, Client ID, Mobile number, Verification code.
- 4. Once you register, view, or download your Demat holdings.

^{*}DPID in the NSDL registration form is the first 8 digits including the prefix 'IN' from your 16 digit demat number. Client ID is the remaining 8 digits.
