Dividend:

The Board also recommended a dividend of Rs. 22 per equity share of Re. 1/- each fully paid up (i.e. 2200 %) for the FY 2024-25, subject to the approval of the shareholders. The record date for determining the eligibility of members entitled to receive the said dividend is Friday, June 27, 2025.



Please note that the Board Meeting commenced at 11.00 a.m. today, i.e. on April 19, 2025 and the said financial results and dividend were approved by the Board at 1.10 p.m. Thereafter, the Board meeting continued for consideration of other agenda items.
