The willing persons shall be required to register themselves online. The Public Notice and detailed procedure for registration is available on the departmental website i.e. [www.haryanatax.gov.in](http://www.haryanatax.gov.in). The interested bidders may also obtain copy of instructions from the office of DETC (X), Kathal.

4. The detail of Zone of vends in the District and Venue for evaluation of e-Tenders shall be conspicuously displayed in the office of DETC (Excise) and DETC (ST) concerned. The list shall also be available on the departmental website i.e. [www.haryanatax.gov.in](http://www.haryanatax.gov.in). Any further clarification in this regard may be obtained from the office of DETC (X), Kathal.

5. The allotment shall be valid for the period from date of allotment to last day of excise year 2022-23 i.e. 11.06.2023, subject to provisions of the Haryana Excise Act, 1914, rules framed thereunder and the instructions issued from time to time.

6. The reserve price of this zone has been further reduced as per the provisions of clause 2.17 of the Haryana Excise Policy for the year 2022-23. The reserve price and quota of CL & IMFL of the above mentioned zone for remaining period of allotment is available in the excise arrangement uploaded on the department website and it will also be pasted on Notice Board in the office of DETC (X) and DETC (ST) concerned. Any further clarification may be obtained from the office of DETC (Excise), Kathal.

7. The earnest money shall be payable as per clause 2.15 of the Excise Policy for the year 2022-23. The schedule for depositing the security and license fee shall be as per clause 6.6 of the Excise Policy for the year 2022-23.

8. The CL & IMFL quota shall be equal to the unutilized basic quota of the respective zone and shall be reflected in the excise arrangement. The licensee will be allowed to lift basic quota of CL & IMFL in accordance with the provisions of clause 3.3.4 of the Haryana Excise Policy for the year 2022-23. The licensee shall also be allowed to lift additional quota upto 50% of basic quota as per provisions of the excise policy. For any further detail regarding this zone, kindly see the excise arrangement duly uploaded on departmental portal.

9. The re-allotment shall be done at the risk and cost of original allottee. The original allottee shall be liable to make up any deficiency incurred by the state as a result of the re-allotment of this zone.
