


- After clicking on save button your LBT tax amount challan will get generated.
The make payment button is on the challan . Please click on that button




6. After clicking on make payment button select payment gateway provider as HDFC Bank (BillDesk)

Then select mode of payment as Net Banking


After selecting those options please click on proceed button.
